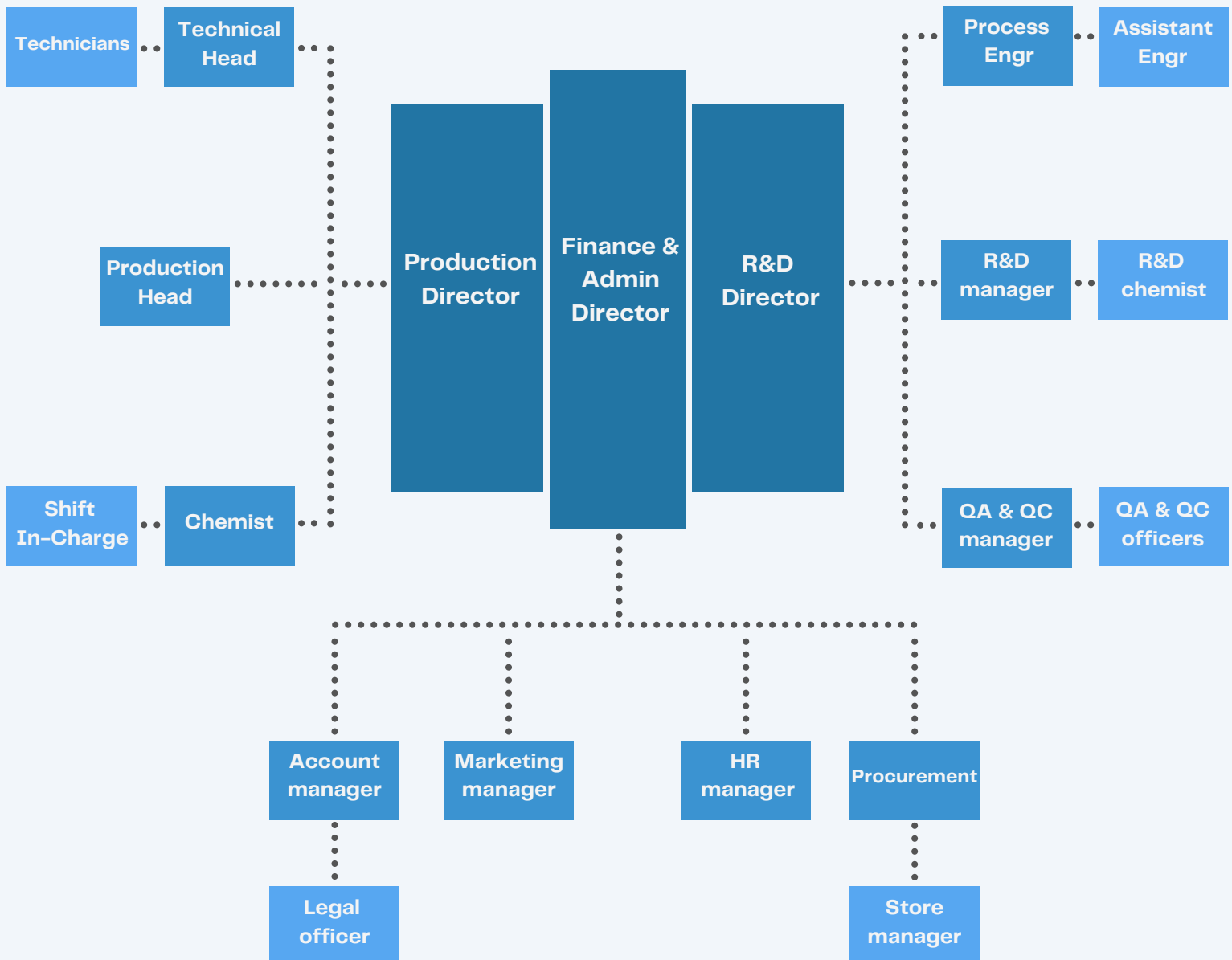

Quality Assurance

The prime responsibility of the Quality Assurance department is to ensure the implementation of quality systems and good manufacturing practices as per ICH Q7 guidelines.

Quality Assurance department handles implementing various QA systems viz. implementation of SOPs, Document change control, Out of Specification investigation, Deviation control, Market complaints, Training, Batch release, and so forth.

The respective department will draft the SOP and send it to QA; QA will check the feasibility of the SOP with the current standard and issue the SOP for the implementation.

All SOPs, Deviations, Change Control and OOS Check Reports, Verification Protocols are approved by the Head of QA.

The QA department handles issuing controlled copies of blank BMRs for production for day-to-day manufacturing activities.

Review of all completed batch documents and release of the finished products based on batch review is the responsibility of QA.

The quality assurance department handles conducting in-house audits and training.

The company also respect and follow the laws and guidelines of the supplying country before starting the business.
